FOR THE PROCUREMENT OF SECURITY SERVICES 2019

- The Plaridel Water District, through the Corporate Budget approved by the Board intends to apply the sum of Two
 Million Five Hundred Twenty Thousand Pesos only (Php2,520,000.00) being the Approved Budget for the Contract
 (ABC) to payments under the contract for SECURITY SERVICES 2019. Bids received in excess of the ABC shall be
 automatically rejected at bid opening.
- 2. The Plaridel Water District now invites bids for Procurement of SECURITY SERVICES 2019. Delivery of the Goods is required the next day upon the receipt of Notice to Proceed. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act":
- (i) Select this paragraph if conditions (a), (c), and (d) under Section 23.4.1.2 of the IRR of RA 9184 do not exist: Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

5. A complete set of Bidding Documents may be acquired by interested Bidders on September 25, 2019 from the address below and upon payment of the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. Bids must be duly received by the BAC Secretariat at the address below on or before October 15, 2019 at 1:00pm. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on 1:01pm, October 15, 2019 at Plaridel Water District, A.C. Reyes St., Poblacion, Plaridel, Bulacan. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 7. The Plaridel Water District reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
