RESOLUTION NO. 81 SERIES OF 2019

RESOLUTION TO APPROVE THE RECOMMENDATION OF THE MANAGEMENT TO RESORT TO SHOPPING AS AN ALTERNATIVE METHOD FOR THE PROCUREMENT OF THE CHRISTMAS GIVEAWAYS TO PLARIDEL WATER DISTRICT (PLAWD) OFFICERS AND EMPLOYEES

WHEREAS, as per Article IV Section 10 of RA 9184, all procurement shall be done through Competitive Bidding, except as provided for in Article XVI or the Alternative Methods of Procurement of this Act;

WHEREAS, as per Resolution No. 1 s 2019, the Board approved the PLAWD Budget for CY 2019 which include, under Miscellaneous Expenses, an allotted budget for the Christmas Giveaways to PLAWD officers and employees for Php280,000.00;

WHEREAS, instead of Competitive Bidding, the management recommended to resort to Shopping for the procurement of the Christmas Giveaways to PLAWD Officers and Employees;

WHEREAS, Shopping is a method of procurement of Goods whereby the Procuring Entity simply requests for the submission of price quotations for readily available off-the-shelf goods or ordinary/regular equipment to be procured directly from suppliers of known qualifications;

WHEREAS, Section 48.1 of the Revised IRR of RA 9184, states that the procuring entity may resort to any alternative methods of procurement subject to the prior approval of the Head of Procuring Entity (HoPE), and whenever justified by the conditions provided in this Act;

WHEREAS, the approved allotted budget for the Christmas Giveaways to PLAWD Officers and Employees shall be included in the Approved Annual Procurement Plan (APP);

NOW, THEREFORE, BE IT RESOLVED, as it is HEREBY RESOLVED, to approve the recommendation of the management to resort to Shopping as an Alternative Method for the Procurement of the Christmas Giveaways to Plaridel Water District (PLAWD) Officers and Employees.
