#### RESOLUTION NO. 45 Series of 2021

RESOLUTION APPROVING THE
UNDERTAKING OF THE PARULAN-BANGA II INTERCONNECTION PROJECT,
AND CHARGING OF THE THREE HUNDRED EIGHTY-TWO THOUSAND SIX PESOS
AND TWENTY CENTAVOS (PHP382,006.20) AGAINST THE
GENDER AND DEVELOPMENT(GAD) PROGRAM'S BUDGET
FOR SAID PROJECT'S CONSTRUCTION COST

WHEREAS, the Parulan-Banga II Interconnection Project shall interconnect the proposed Cubao St.-NIA Road, Banga II Pipe-Laying Project to the existing 150 mm dia. PVC pipe laid along the Plaridel-Pulilan Diversion Road to boost the water supply and pressure needed by the residents of Vergel De Dios St., Cubao St., Leonardo St. and other areas in Banga II;

WHEREAS, this pipeline extension project was proposed to be undertaken and be connected to the proposed Cubao St.-NIA Road, Banga II Pipe-Laying Project after several houses along the end of the affected NIA road were demolished, and a new road was constructed by the NIA administration last March 2021 as part of the government's anti-obstruction ordinance;

WHEREAS, the undertaking of the said interconnection project seeks to (1) provide the affected areas with additional tapping point where a more stable source and a lesser number of residents are connected, (2) increase water pressure and stabilize the water supply requirements of the affected residents, (3) minimize the water demand requirement of the already 'over-saturated' 200-mm diameter PVC main transmission line along Gen. Alejo Santos Highway and divert its demand to the proposed pipeline supplied by the Parulan Pump Station, and (4) accomplish the said project under PLAWD's Gender and Development (GAD) Program;

WHEREAS, the revised cost for the Interconnection Project is Three Hundred Eighty-Two Thousand Six Pesos and Twenty Centavos (Php382,006.20), instead of its former cost amounting to Two Hundred Thirty-Two Thousand One Hundred Seventy-Seven Pesos (Php232,177.00);

WHEREAS, the revised cost includes the increase in the proposed pipe size and length, from the former 402 linear meter of 2" diameter PVC pipe to 520 linear meters of 4" diameter PVC pipe, for the purpose of increasing the pipes carrying capacity and interconnect it to the proposed Cubao St.-NIA Road Pipe-Laying Project;

WHEREAS, the said revised cost was not included in this year's Project Procurement Plan, however, it shall be part and charged against the GAD Program's budget, instead of a budget re-alignment from the Repair and Maintenance of Transmission and Distribution Lines;

WHEREAS, through a Recommendation dated 27 May 2021, the Engineering and Technical Division recommended for the Board to approve the undertaking of the Parulan-Banga II Interconnection Project, and charging of the Three Hundred Eighty-Two Thousand Six Pesos and Twenty Centavos (Php382,006.20) against the GAD Program's budget for the said project's construction cost;
