(3,200,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Security Services PLAWD 2022-11-121. Bids received in excess of the ABC shall be automatically rejected at bid opening. The Plaridel Water District now invites bids for the above Procurement Project. Delivery of the Goods is required by the next day upon the receipt of Notice to Proceed. Bidders should have completed, within Three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders). Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183. Prospective Bidders may obtain further information from Plaridel Water District and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M., Monday to Friday (Except Holidays). A complete set of Bidding Documents may be acquired by interested Bidders on November 22,2022 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPRB, in the amount of Php 5,000.00. The Procuring Entity shall allow the bidder to present its proof

 All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
