 - > for 68-kg Liquid/Gas Chlorine Cylinder > Capacity - 25ppd
 - > Regulator shall have a spring opposed two layer ECTFE (Halar) diaphragm which controls vacuum and closes tight upon loss of vacuum
 - > Regulator shall have machined PVC bodies, tantalum springs , and solid silver inlet valve stem
 - > Regulator shall be equipped with an inlet filter to remove particulate matter from the gas before it enters the inlet safety valve
 - > Design of the regulators shall note rely on any O-ring(s) to prevent pressurized chlorine leaks, into the room, from region upstream of the inlet safety valve.
 - > Regulator shall include a mechanism (red flag indicator) to indicate when the cylinder is empty and requires replacement.
 - > Ejector shall be the water operated venturi nozzle type. The ejector shall provide the operating vacuum for the chlorinator system
 - > The ejector shall incorporate a spring loaded, normally closed check valve to prevent the backflow of water into the chlorine gas equipment. The check valve shall be suitable for back pressures up to a minimum of 145 psi.
 - > Ejector check valve shall automatically close upon the loss of vacuum.
 - > Accessories includes: Yoke Wrench, HDPE tubing, 10 pcs lead gaskets Ammonia Container , Insect Screen, Fittings and Extra Inlet Filter
