Description

INVITATION TO BID FOR Security Services

- The Plaridel Water District through the Corporate Budget approved by the Board intends to apply the sum of Two Million Six Hundred Thousand Pesos only. (2,600,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Security Services PLAWD 2022-08-079. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The Plaridel Water District now invites bids for the above Procurement Project. Delivery of the Goods is required by the next day upon the receipt of Notice to Proceed. Bidders should have completed, within Three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from Plaridel Water District and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M., Monday to Friday (Except Holidays).
- A complete set of Bidding Documents may be acquired by interested Bidders on August 31, 2022 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
- The Plaridel Water District will hold a Pre-Bid Conference on September 8, 2022 at 1:00 P.M. at A.C Reyes St., Poblacion, Plaridel, Bulacan (Plaridel Water District) and/or through video conferencing or webcasting via zoom meeting which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat at the address below on or before September 20, 2022 at 1:00 P.M. Late bids shall not be accepted.
- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- Bid opening shall be on September 20, 2022 at 1:01 P.M. at the given address below Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- The Plaridel Water District reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
