RESOLUTION NO. 52
Series of 2022

RESOLUTION DECLARING THE 2ND FAILURE OF THE COMPETITIVE BIDDING CONDUCTED FOR THE PROCUREMENT OF THE PASSENGER VAN AND APPROVING THE NEGOTIATED PROCUREMENT FOR THE SAME AS AN ALTERNATIVE METHOD OF PROCUREMENT

WHEREAS, the Bids and Awards Committee (BAC) through Resolution No. 2022-029 dated 23 May 2022, recommended to the Plaridel Water District (PLAWD) Board of Directors declaring the 1st failure of the competitive bidding conducted for the procurement of the Passenger Van and approving its immediate rebidding;

WHEREAS, the PLAWD BOD issued Resolution No. 43 series of 2022 dated 10 June 2022, approving the foregoing recommendations;

WHEREAS, PLAWD posted on the Philippine Government Electronic Procurement System or PhilGEPS the Invitation for Bid (IFB) for the rebidding of the Passenger Van with an Approved Budget for the Contract amounting to Php1,720,000.00, the same was posted on PLAWD's website and on conspicuous places in the premises of PLAWD continuously for at least seven (7) days starting 15 June 2022;

WHEREAS, despite the IFB, no bidders purchased the Bidding Documents for the aforesaid procurement;

WHEREAS, two interested bidders namely Toyota Plaridel and Mendo Enterprises, attended the scheduled Pre-bid Conference on 23 June 2022;

WHEREAS, the deadline for the submission and opening of bids was on 05 July 2022 at 1:00 PM wherein no prospective bidders arrived;

WHEREAS, in the absence of any bid proposal until the aforesaid deadline, BAC agreed to recommend to the Head of Procuring Entity (HOPE) to declare the 2nd failed bidding.

WHEREAS, Section 53 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 or the "Government Procurement Reform Act," states:

"Section 53. Negotiated Procurement

Negotiated Procurement is a method of procurement of Goods, Infrastructure Projects and Consulting services, whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant in any of the following cases:

53.1 Two Failed Biddings. *Where there has been failure of competitive bidding or Limited Source Bidding for the second time as provided in Section 35 of the Act and this IRR.*

WHEREAS, BAC Resolution No. 2022-041 dated 05 July 2022, formally recommended the following:

1. To declare the 2nd failure of the competitive bidding conducted for the procurement of the Passenger Van;
2. To recommend the immediate procurement of the same services through negotiated procurement as an alternative method of procurement;
3. To recommend the Procuring Entity to directly negotiate a contract with the technically, legally and financially capable suppliers, contractors or consultants;
4. To recommend for approval by the HOPE the foregoing findings;


NOW, THEREFORE, BE IT RESOLVED, as it is **HEREBY RESOLVED**, do hereby declare the 2nd failure of the competitive bidding conducted for the procurement of the Passenger Van;


RESOLVED FURTHER, that the same services shall be procured immediately through negotiated procurement as an alternative method of procurement;





WHEREAS, BAC Resolution No. 2022-029 declaring failure of first competitive bidding.

WHEREAS, the Plaridel Water District (PLAWD) posted in the Philippine Government Electronic Procurement System (PhilGEPS) the Invitation for Bid (IFB) for the rebidding of the Passenger Van with an Approved Budget for the Contract (ABC) in the amount of PhP1,720,000.00, and posted the same at the PLAWD's website and on conspicuous places at the premises of PLAWD continuously for at least seven (7) days starting 15 June 2022;

WHEREAS, on the scheduled Pre-Bid Conference held on 23 June 2022, two interested bidders attended; Toyota Plaridel and Mendo Enterprises.

WHEREAS, in response to the said invitation, no bidder purchased the Bidding Documents for the contract;

WHEREAS, the deadline for the submission and opening of bids is on 5 July 2022, at 1:00 pm, there were no prospective bidders arrived;

WHEREAS, as stated in the Bidding Document:

"The address for submission of bids is A.C Reyes Street Poblacion Plaridel Water District, Plaridel, Bulacan.

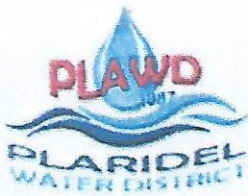
The deadline for submission of bids is [July 5,2022 @ 1:00 P.M.];"
