Description

INVITATION TO BID FOR SUPPLY AND DELIVERY OF G.I. FITTINGS

1. The Plaridel Water District, through the Corporate Budget approved by the board intends to apply the sum of Four Hundred Sixty-Six Thousand Eight Hundred Thirty Pesos Only (Php 466,830.00) being the ABC to payments under the contract for Supply and Delivery of G.I. Fittings. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Plaridel Water District now invites bids for the above Procurement Project. Delivery of the Goods is required to comply with the delivery schedule stated in Section VI Schedule of Requirements. Bidders should have completed, within one (1) year from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from Plaridel Water District and inspect the Bidding Documents at the address given below during Monday to Friday, from 8:00 am to 5:00 pm.

5. A complete set of Bidding Documents may be acquired by interested Bidders on July 04, 2023 from the given address and website(s) below A.C. Reyes St., Poblacion,

Plaridel, Bulacan and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Hundred Pesos (Php 500.00).

6. The Plaridel Water District will hold a Pre-Bid Conference¹ on July 12, 2023 at 1:00 PM at Plaridel Water District and/or through video conferencing or webcasting via Zoom or Google Meet, which shall be open to prospective bidders.

1 May be deleted in case the ABC is less than One Million Pesos (Php1,000,000) where the Procuring Entity may not hold a Pre-Bid Conference.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before July 24,2023 at 1:00 PM. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on July 24,2023 at 1:01 PM at the given address below. A.C. Reyes St., Poblacion, Plaridel, Bulacan. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Plaridel Water District reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
