RESOLUTION NO. 10
Series of 2023

RESOLUTION AUTHORIZING ENGR. REYNANTE D. FRANCISCO, THE OFFICER-IN-CHARGE OF THE PLARIDEL WATER DISTRICT (PLAWD), TO APPROVE PROCUREMENTS OF GOODS, SERVICES, AND/OR INFRASTRUCTURE PROJECTS AMOUNTING TO PHP100,000.00 AND BELOW, AND TO SIGN FOR AND ON BEHALF OF PLAWD, THE RESPECTIVE MEMORANDUMS OF AGREEMENT/CONTRACTS THEREFOR, IF REQUIRED

WHEREAS, the Plaridel Water District's (PLAWD) Management deemed it right to set the amount of approving limitation to sustain the advocacy of the District in promoting transparency, accountability, and corruption-free values;

WHEREAS, under Resolution No. 261 series of 2016 dated 28 October 2016, the PLAWD Board of Directors (BOD) agreed that the procurement amount exceeding Php100,000.00 shall be approved by the Head of the Procuring Entity (HoPE) and those below shall be approved by the General Manager;

WHEREAS, the procurements of goods, services, and/or infrastructure projects amounting to Php100,000.00 and below are subject to the General Manager's review and approval;

WHEREAS, the PLAWD BOD issued Resolution No. 90 series of 2022 dated 22 December 2022, approving the designation of Engr. Reynante D. Francisco, Division Manager B of the Engineering and Technical Division, as the Officer-In-Charge (OIC) of the Plaridel Water District effective 01 January 2023 unless sooner revoked and until the designation of the LWUA-appointed Interim General Manager;

WHEREAS, there is a need to authorize Engr. Francisco, PLAWD's OIC, to approve procurements of goods, services, and/or infrastructure projects amounting to Php100,000.00 and below;

WHEREAS, upon the approval of the procurements of goods, services, and/or infrastructure projects, respective Memorandums of Agreement (MOAs)/Contracts are being signed, if required;

WHEREAS, there is a need to authorize as well Engr. Francisco, PLAWD's OIC, to sign for and on behalf of PLAWD, the respective MOAs/Contracts, if required, for the procurements of goods, services, and/or infrastructure projects amounting to Php100,000.00 and below;

NOW, THEREFORE, BE IT RESOLVED, as it is **HEREBY RESOLVED**, do hereby authorize Engr. Reynante D. Francisco, the Officer-in-Charge (OIC) of the Plaridel Water District (PLAWD), to approve procurements of goods, services, and/or infrastructure projects amounting to Php100,000.00 and below;


RESOLVED FURTHER, that Engr. Francisco, PLAWD's OIC, be authorized to sign for and on behalf of PLAWD, the respective Memorandums of Agreement (MOAs)/Contracts, if required, of the approved procurements of goods, services, and/or infrastructure projects amounting to Php100,000.00 and below;

RESOLVED FINALLY, that a list of all MOAs/Contracts for the procurements of goods, services, and/or infrastructure projects amounting to Php100,000.00 and below signed by Engr. Francisco, PLAWD's OIC, be presented during every meeting of the PLAWD Board of Directors.


