INVITATION TO BID FOR Security Services for CY 2026

1) The Plaridel Water District, through the Corporate Budget approved by the Board intends to apply the sum of Five Million Two Hundred Thousand Pesos Only (5,200,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Security Services for CY 2026 PLAWD 2025-10-070. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2) The Plaridel Water District now invites bids for Security Services for CY 2026 using the Delivery of the Goods is required the next day upon the receipt of Notice to Proceed. Bidders should have completed, at least Three (3) years, from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.

i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens,

pursuant to RA No. 5183.

ii) Bidding is open to all interested Bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR.

4) Interested Bidders may obtain further information from Plaridel Water District and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM, Monday to Friday (Except on declared Holidays and Work Suspensions).

5) A complete set of Bidding Documents may be acquired by interested Bidders on October 10,2025 from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos Only (10,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
